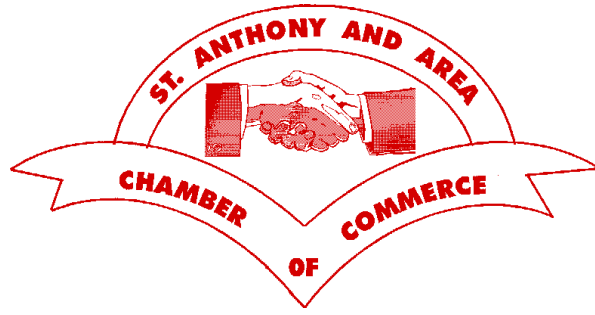

INTRODUCTION

The **ST. ANTHONY AND AREA CHAMBER OF COMMERCE** is a non-profit organization that has been in existence since the late 70's and has become a very prominent business based organization in the region. The **CHAMBER** currently serves all communities between Goose Cove and Cook's Harbour and has approximately 70 members. There is an executive committee in place and it has a coordinator position paid fully by your membership fees.

MANDATE

It is the **CHAMBER'S** mandate to promote and improve trade and commerce and the economic, civic and social welfare of the district.

MEMBERSHIP

Any reputable person, directly or indirectly engaged or interested in trade, commerce or the economic and social welfare within the district shall be eligible for membership in the **CHAMBER**. Membership fee is \$100 per year. Members are given the opportunity to have input in issues concerning our area.

EVENTS/ACTIVITIES OF YOUR CHAMBER

◆ **JUNIOR ACHIEVEMENT** - An educational program that is delivered to students in the area to inspire them to value free enterprise, understand business and economics and develop entrepreneurial and leadership skills. Feel free to volunteer your time to this worthy program.

◆ **ST. ANTHONY WELCOME WAGON** - This is a program that welcomes new residents to the community and makes them aware of the services and businesses that are available to them. Your involvement in this program allows you to promote and market your business.

◆ **QUARTERLY NEWSLETTER** - Keeps members informed of how the **CHAMBER** is working to serve you.

◆ **VISITOR INFORMATION CENTRE** - It allows businesses in the area to promote themselves while supplying tourists with information about the local sites and operators. Referrals are given to members first and non-members second. The center operates annually during the summer months and employs several students funded by the Provincial Tourism Board.

◆ **SPECIAL ACTIVITIES & EVENTS** - Your **CHAMBER** throughout the year organizes and promotes special events on an ongoing basis.
